Articles of Continuance (transition)

8 The classes, or regional or other groups, of members that the corporation is authorized to establish

The Corporation is authorized to establish one class of members. Each member shall be entitled to receive notice of, attend and vote at all meetings of the members of the Corporation.

9 Statement regarding the distribution of property remaining on liquidation

In the event of dissolution or winding up of the Corporation all its remaining assets after payment of its liabilities shall be distributed to one or more Hungarian groups in Ottawa that pursue activities in the spirit of the goals of the Corporation as stated in Article 6. Furthermore, should the Corporation be a soliciting corporation at the time of its dissolution, the recipients of its remaining assets shall be restricted to primarily Canadian-Hungarian "qualified donees" within the meaning of subsection 248(1) of the Income Tax Act (Canada).

10 Additional provisions, if any

The directors may appoint one or more additional directors who shall hold office for a term expiring not later than the close of the next annual meeting of members, but the total number of directors so appointed shall not exceed 1/3 (one-third) of the number of elected directors elected by the members at the previous annual meeting of members. The corporation shall be carried on without the purpose of gain for its members, and no part of the income of the Corporation can become payable to, or available for the personal benefit of any member. The amendment or repeal of any by-laws requires special resolution by the members.
